

#### MINUTES OF THE IC MEETING HELD ON 1st MARCH 2023

A meeting of the Internal Committee was held online on Wednesday,  $1^{st}$  March 2023 at 4.30 pm on the MS TEAMS platform. The minutes of the meeting are as follows:

- The meeting was attended by 09 (Nine) members including internal and external members of IC.
- 2. Leave of absence was sanctioned to Ms. Samata Kadam, Head Clerk, SIES (Autonomous) College, Sion (West) Mumbai.
- 3. Agenda No. 1: To acquaint the members with the role of IC in the college The Chairperson, Dr. Neeraja Tutakne, welcomed the external Legal Expert, Ms. Snehal Velkar and other members to the meeting. The Chairperson explained the role of the IC and the need to prevent sexual harassment of women in the workplace. She also mentioned that the committee did not receive any complaints for the academic year 2022 -23.
- 4. Agenda No. 2: To understand the legal technicalities involved in the overall functioning of IC Ms. Velkar explained the legal aspect of handling cases of sexual harassment. She highlighted a few points:
  - That "Complaint" in the title of ICC should be removed due to the interim court ruling. The committee to now be called Internal Cell.
  - That the Internal Cell is purely for sexual harassment cases by women.
  - A written complaint to be procured from the complainant. A report to be submitted
    by the committee within 90 days of receiving such a complaint and action to be taken
    by the institution within 10 days of receiving the report.
  - That the complainant be provided with two options in addressing a complaint:
    - Reconciliation which would mean reprimand only without any enquiry and legal action.
    - Conduct enquiry and initiate subsequent proceedings.
